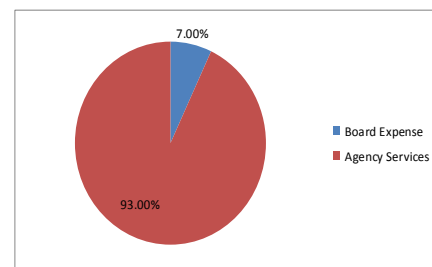

During FY16 Board and Staff, in accordance with the Strategic Plan, worked diligently to improve the ADAMHS continuum of care as highlighted below.

Improved Board Operations:

- Approved cohesive Bylaws revisions
- Approved new comprehensive Policies
- Developed new Board Member Handbook
- Welcomed three new members (Ms. Cary Wise, Mr. Allan Baer and Mr. Marc Jensen)
- Approved one new staff position (Manager of Clinical Services and Quality Improvement)

Enhanced Recovery Support Services:

- Approved new funding for two Health Officers at the Link
- Approved new funding for Emergency Services at Children's Resource Center
- Approved new funding for Male Recovery Housing provided by the Zepf Center
- Approved new Mercy Health St. Charles contract to expand psychiatric hospital capacity
- Implemented "Project Direct Link" providing jail based Vivitrol and follow-up treatment
- Increased "NET-Plus" free transportation for mental health and substance abuse treatment
- Approved new funding for "211 Recovery Helpline" to increase awareness and access to services
